#### **Animal Shelter**

- Saved 96% of the animals in our care.
- Intakes: 69 (19 owner surrender, 1 return adoption, 42 from animal control, 5 strays and 2 transferred in).
- Outcomes: 62 animals adopted, 1 died, 2 were euthanized for illness or aggression, 0 animals were owner requested euthanasia, 10 were returned to their owners and 31 were sent to rescue.
- Clinic performed 176 spay/neuter surgeries.
- 8 dogs were treated for heartworms
- 102 large dogs, 6 small dogs, 15 puppies, 9 cats and 9 kittens in the facility.
- 10 animals being held for court.
- 96 animals available for adoption and 74 of those are spayed/neutered (77%).
- PAWS received \$504.00 in donations.
- PAWS held the 2nd annual "Trick or Treat the Halls of PAWS" event and had 1,643 visitors come through the facility. It was an amazing opportunity to love on our community and the costumes were incredible.

### **Solid Waste**

- Anderson County Solid Waste put out a Public Notice of Filing a Major Permit Modification Application for the Starr Landfill LCD to be converted to a C&D in the Independent Mail as required by DHEC.
- Evaluated loads coming in at the MRF from the convenience centers and the recycling route to determine contamination issues so that they can be addressed.
- Environmental Enforcement went to court this week on 7 cases. Four Littering, One Unlawful Dumping and two Failure to Comply were found guilty. Six out of seven did not show up for court.
- Environmental Enforcement educated residents on covering their loads and not to litter at the Whitefield and White Street Convenience Centers.
- Environmental Enforcement has been working the area of Pearl Harbor Way and Old Trail Dr. with issuance of Cleanup Orders. There was one individual fined due to not complying with a cleanup order.
- Staff collected the 85 trees awarded by the Palmetto Pride Tree Grant and delivered them to the Town of Belton, Town of Pendleton and Mt Zion Presbyterian Church.

• Completed the Litter Prevention Grant to request \$10,000 to purchase cargo nets to give away at the busy convenience centers to encourage residents to properly cover and secure their loads.

- Keep South Carolina Grant was completed and submitted. This grant is requesting \$10,000 to cover the costs of our calendars that are created with the Anti-Litter Art Contest, cleanup supplies, travel costs to the state and national conferences and promotional items.
- Delivered 2 roll carts to Hunt Meadows Elementary to help with their recycling program.
- Shipped out 1 tractor trailer load of green glass, 1 load of brown glass and 1 load of clear glass.
- Refurbished a compactor and installed it at the old TTI building for recyclables.
- Staff continues to work to recruit Adopt-A-Spot groups to help clean up the littered roads and areas in our county. We have 77 active Adopt-A-Spot groups.
- We have 3 inmates for the convenience centers and 4 for the MRF this week due to a shortage of inmates on work detail at the Detention Center.
- <u>Solid Waste has 3 Full-time vacancies</u> in the department which includes 1 Truck Driver (Class A) ,1 Equipment Operator and 1 Laborer. We also have 3 <u>Part-Time Ambassador vacancies</u>.
- **Did you know?** Recycling 100 aluminum cans saves enough energy to keep the lights on in your bedroom for 2 weeks.

#### Stormwater

- Allison Square Apartments responded to the two letters requesting they address flooding problems. An engineer will evaluate the storm system to determine how to correct the parking lot flooding.
- Staff met with Richard Kay site representatives about permit close-out requirements.
- Hemlock Subdivison Phase II was issued a cease and desist for failure to adequately grass disturbed areas, repair erosion, and maintain stormwater controls.
- Reviews were conducted for Carolina Auto Auction (1st), Mayfield Woods Subdivision (3rd), Piedmont 7-Eleven (2nd), and Upstate Industrial Lot 18 (3rd).
- Received resubmittal for Powdersville Towne Outparcels 2 & 4 and Exchange Logistics Park.
- Received new application for Stop-a-Minit #32 on the corner of Hwy 88 and Liberty Hwy.

#### Wastewater

#### Pretreatment

- Began filling in the lengthy NPDES Permit Renewal Application Form. Once this form is completed and all lab data has been received and included, this will be provided to our environmental engineers for review prior to submittal.
- Assisted Re-Wa with transition of locates in the area north of Highway 8. We are providing them with the locate emails received for that area and the opportunity to train with our locate team to learn the locations of the collection system.
- The National Association of Clean Water Agencies (NACWA) contacted this department regarding a voluntary nutrient survey to be conducted by EPA. They are having a webinar on the subject for wastewater agencies to view that will assist in determining whether participation will be beneficial. They hope to have the webinar available to view by Friday, November 1. Upon availability, this will be viewed so that we can make an educated decision as to participation in the survey.

### Administration

- Meeting was held with ReWa to discuss transition of all services that is currently being performed by Anderson County. Proposed date of 12/16 to have all services tuned over to ReWA,
- Meeting with Water Districts to discuss billing and collecting agreements.

#### Engineering

- Attended pre-bid meeting for Welpine sewer project.
- Reviewed maintenance project on Dixon Rd.
- Provided fee information for proposed phase II of Shackleburg Farms.

#### ROW

- Located and marked a manhole with a post on Metro Dr. The manhole was covered with 4 foot
  of fill dirt and debris. We will raise it in the near future by adding a 4-foot precast manhole
  section.
- Cleaned section of 8-inch sewer line on Quail Hollow in Cobbs Glen. This was a preventive cleaning; the line has given problems in the past with roots entering at a service tap.
- One manhole was located with our CCTV unit and raised on Clemson Blvd. at Fuddruckers this week; raised it 14 inches to grade

• Cutting is complete on the Pheasant's Ridge, Old Portman Rd., and New Prospect Church Rd. lines this week.

#### 6&20 WWTP

- Second monthly parameter tests for the month of October are all within SCDHEC limits.
- Drained digester onto one bed this week. The drying beds are drying slower due to the wet and cooler weather.

## Locating/Inspections

- Pump station and ROW crews assisted in the force main locating off Harris Bridge Rd and Lebanon Rd. Due to the lack of workable area along the shoulders, the potholing was performed by hand at each location. The force main was spotted at seven different locations within the SCDOT project parameters.
- Staff and department engineer met a contractor onsite to re-confirm the correct course of action on the refurbishment of five manholes deteriorating within our sewer system due to age and sewer gases.

## **Pump stations**

- Replaced the alternator at Clemson Research.
- Pulled pump #1 at Northbound Rest area because of long run times, we cleaned the trash out of pump and put back into service.
