Ballot Questions

Our government representatives sometimes ask voters questions when they vote. Several are on the ballot this year. This statewide questions has been asked by the SC General Assembly.

Statewide Constitutional Amendment

Must Section 4, Article II of the Constitution of this State, relating to voter qualifications, be amended so as to provide that only a citizen of the United States and of this State of the age of eighteen and upwards who is properly registered is entitled to vote as provided by law?



Yes, In Favor of the Question

No, Opposed to the Question

The effect of this question is to amend the SC Constitution to limit the right to vote in to citizens of the United States and the State of South Carolina who are properly registered and entitled to vote. The state constitution is currently silent on voter registration, although state law requires a person to register to vote to be entitled to vote.



Ballot Questions

Our government representatives sometimes ask voters questions when they vote. Several are on the ballot this year. These countywide questions have been asked by Anderson County Council.

Anderson County Transportation Sales Tax Questions

X **Question 1:** Approve an additional local 1% sales tax to fund road and bridge projects ([read the full question here](#)).

If approved, an additional penny sale tax will be imposed beginning in May 2025 that will last for 7 years or until \$366 million is raised, whichever occurs first. The sales tax does not apply to groceries.

✓ **Question 2:** Approve issuing \$15 million in general obligation bonds to be repaid from the proceeds of the sales tax in Question 1 ([read the full question here](#)).

Ballot Questions

Our government representatives sometimes ask voters questions when they vote. Several are on the ballot this year. This question has been asked of voters in the Corinth-Shiloh fire district by Oconee County Council.



Corinth-Shiloh (Oconee County) Special Tax District

Do the voters favor the creation of a special tax district for the purpose of providing fire protection services in the district. If the question is approved, the district will be created and a special election will be held to elect five district commissioners. Also, if the question is approved, the voters will authorize a maximum tax levy of 25 mills.

Corinth-Shiloh fire district is currently a volunteer fire district.
